- Ⓜ Temporary grand opening signs are permitted for a period not to exceed 15 calendar days.
- Ⓜ One sign per event is allowed.
- Ⓜ The surface display area, per side, can be no larger than 35 square feet.
- Ⓜ Grand opening signs must be located on the same premises as the business.
- Ⓜ Wind blown devices (pennants, flags, spinners, & streamers) are permitted if a written request is submitted.
- Ⓜ They must be a minimum of 10 feet from the property line & a minimum of five 5 feet from any sidewalk.
